GTA Telecom LLC d/b/a GTA ("GTA") files the enclosed revised Tariff for the Rate and Charge for an existing product and a deletion of pricing for a discontinued product.

- Section 7, Original Page No(s). 58

GTA has discovered that its current Tariff has a provision for Add/Drop Multiplexing in Section 7 page(s) 55 and 56 but does not have pricing for the service in its Rates and Charges Section Original Page 58. As such, GTA respectfully submits its revised Rates and Charges in the above-mentioned Tariff page. GTA has elected to concur with the National Exchange Carrier Association ("NECA") tariff on file with the FCC. The NECA rate pages showing GTA's rate determination for Add/Drop Multiplexing are enclosed with this filing. GTA is also submitting its rate band designation under NECA so that the GPUC may see where rates are derived from. Further validation of NECA rates may be verified at www.NECA.org.

GTA also has discovered that above-mentioned page 58 still provides for a DSL Access Service Connection charge. GTA has discontinued this service in the General Exchange Tariff and therefore this tariff rate is no longer valid. As such, GTA wishes to delete the rate from its Tariff.

In accordance with the notice provisions of Section 12106(b) of the Guam Telecom Act, GTA requests that the Commission approve this filing to be effective 30 days hence, on May 4, 2009. Since 30 days for the filing falls on a Saturday, GTA has made the effective date on the following business day. An original and one (1) copy of the tariff revisions are enclosed.
