Teleguam Holdings LLC, d/b/a GTA hereby provides the undersigned excavation clearance pursuant to the requirements of Chapter 71 of Title 21 of the Guam Code. This Clearance is subject to the Terms and Conditions and Requirements stated herein.

GTA will mark the approximate routing of its buried cable, but will not be responsible for any excavation activities. The undersigned **shall not excavate within 1.5 feet on either side of said cables, and shall take extreme caution when excavating around said markings and facilities specifically within concrete sidewalks, asphalt, and hard rocky areas. GTA will not be held responsible for the cable depth, non existence of warning tape or bedding sand within our facilities,**

Notwithstanding unforeseen weather conditions, the undersigned shall insure that all previously established markings are visible, and shall immediately request GTA to reestablish the markings in the event that they become unclear. The clearance provided herein is limited to the immediate area requiring excavation and marked by GTA. In the event of large scale developments requiring additional site visits or inspections by GTA, incremental clearances will be required.

**\* Clearance requests received after 3:00 PM will be processed the next working day.**

**\* Accounting must approve applicant for Cable Clearance. This may take up to 3-5 working days.**

**\* Clearance is only valid for a period of ten (10) days from date the clearance was given.**



## REQUIREMENTS

- \* If approved GTA will schedule the clearance 1 to 2 day prior to said construction date. If denied, the GTA's Accounting Department will contact Requestor with reason.
- \* If a DPW Encroachment Permit is required, Requestor must obtain such permit directly from DPW. GTA's clearance is only provided for purpose of identifying its cable for excavation purposes.
- \* When approved by DPW the customer must call GTA 24 to 48 hours (excluding holidays and weekends) before start of projects.
- \* Requestor is responsible for obtaining from the necessary party(ies) all necessary permit(s) for the excavation on private property, easements or rights of way and shall indemnify and hold GTA harmless for any and all liability relating to the excavation.
- \* The Compliance Officers will mark all GTA facilities one (1) foot or more if needed. **(Footage distance depends on the project to be cleared).**
- \* Under no circumstances shall GTA's issuance of the requested Excavation Clearance shall be considered a grant, license or permit to use any GTA facility, property, easement or right of way.

**DAMAGES FOR REPAIR.** Pursuant to Guam Code Title 21, Section 71109 - Any person who damages a utility line or roadway is subject to pay for all costs incurred by the operator to restore the utility or roadway to its original condition. If the operator of a utility fails to present the contractor within sixty (60) days after the damage has been repaired, the utility operator may not withhold excavating clearance for other projects which clearance have been requested. The undersigned hereby acknowledges that in the event of damage it is liable to pay for all costs incurred by GTA to restore the utility or roadway to its original condition. **Additional clearances will not be processed by GTA unless GTA has received full payment for damages claimed as payment is "Due Immediately Upon Receipt of GTA Invoice".**

**FAILURE TO OBTAIN GTA ADVANCE CLEARANCE. Civil Penalties.** Pursuant to Title 21 of the Guam Code Section 71110 - Any person who violates any provision of Chapter 71, including but not limited to the failure to obtain clearance, may be subject to a civil penalty no to exceed Five Thousand Dollars (\$5,000.00) for the first violation, and not to exceed ten Thousand Dollars (\$10,000.00) for each successive violation within a five (5) year period.

- \* The undersigned represents and warrants that he/she is authorized of behalf of the requesting party to execute this Clearance Request and that terms and conditions.
- \* In order to identify the precise location requiring clearance, the undersigned is required to meet with GTA's Right-Of-Way personnel at the Proposed Site for markings of GTA buried cables upon set date and time.
- \* **A copy of the approved GTA clearance must be readily available at the site.** At random, the Company may perform field inspections, however it does not relieve the undersigned from the above compliances.
- \* The undersigned assumes full responsibility for any subcontractor or original contractor liability for damages suffered by GTA. All incurred costs caused by these contractors shall be paid in full by the undersigned and left at the burden of the undersigned to recover his loss.
