Pursuant to the GPUC order in GTA Docket 12-12,¹ Teleguam Holdings LLC ("GTA") hereby provides this notice of changes made by the National Exchange Carrier Association ("NECA") to its Tariff F.C.C. No. 5 Access Service. NECA Tariff Transmittal No. 1389 was filed with the Federal Communications Commission on June 17, 2013 to become effective July 2, 2013.

Attached hereto are the relevant pages of NECA Tariff Transmittal No. 1389 including rates for Ethernet Transport Services. These updated rates shall replace the GTA General Exchange Tariff No. 1 Metro Ethernet rates last updated January 1, 2013.² Note that Rate Band 5 continues to apply.

This filing is made in response to the Federal Communications Commission's orders¹ related to the 2013 annual access tariff filing; the Office of Managing Director's Public Notice² announcing the universal service contribution factor for the third quarter of 2013; and under authority of the Commission's Special Permission Nos. 02-077 and 13-014.

This filing revises rates for interstate access service provided by Telephone Companies participating in NECA Tariff F.C.C. No. 5, pursuant to section 69.3 of the Commission's Rules. Specifically, the filing revises End User Common Line, Federal Universal Service Charge, Access Recovery Charge and various special access services rates. In addition, this filing reflects changes to the listings of companies participating in the tariff.
